## **COURSE OBJECTIVES:**

Group members will be able to:

- 1. List 8 themes that trans people can use to cope with transphobia at work.
- 2. Predict issues that may exacerbate postpartum depression for pregnant transmen.
- 3. Discuss how pregnant transmen work to manage others' perceptions of them.
- 4. Describe how assisted reproductive technologies can expand options for TGNC individuals and their partners.
- 5. Assess the impact of various TGNC medical treatments on individuals' fertility.
- 6. Explain 3 essentials for minors incapable of giving fully informed consent to still assent to treatment.
- 7. Analyze how discrimination results in health disparities for TGNC people.
- 8. Predict the factors most likely to result in conflict with a child when a parent transitions.
- 9. Explain how medical care for a neovagina differs from care for a natal vagina.
